# The Neighborhood Council of Westchester/Playa del Rey Board of Directors' Meeting – October 2, 2007

**Item A**: The meeting was called to order at 6:45 PM by Mike Arias, President of the Board. The Roll was called. Self introductions were made.

Cyndi Hench asked that it be noted in the Minutes that DONE Representative, Lisette Covarrubias, was going to research the necessity of a having a quorum at standing/ad hoc committee meetings, and give an answer at the October meeting. The Motion that the Minutes be approved as corrected passed unanimously.

#### **Public Comment:**

- Steven Jirucha Playa del Rey Resident the ocean location looks good but what about the impacts of construction on roads in PdR that are already too torn up? A 28" pipeline carrying natural gas only 3 feet from surface, it seems like a good target for terrorists. I live within a mile of that pipe and would probably be killed put the pipe deeper in the ground.
- Karen Kanter Playa del Rey Resident This could be a fabulous project but we are already beat up in this community with projects that don't benefit us only place hardships on us. We can't take it any more.

- Thea Geller – Playa del Rey Resident – submitted for the record "The community of Playa del Rey is under siege by developers, City Planning, DOT, CalTrans and just in opposing further pollution, right of way, infiltration by outside, non-essential interests. We look to Neighborhood Council of Westch-Playa del Rey to uphold and defend our rights, <u>not</u> sell us out or compromise them. Shame on you for entertaining this project."

**Item G:** Motions/Actions Items: (Public comment on agendized items limited to 2 minutes)

- 1. Motion to approve proposed Bylaw changes or portions thereof (Voss) –
- Voting Residential District separation delineation item failed unanimously at committee.
- A term limit of 8 years on board has been prescribed by DONE.
- Article III Boundaries The area in question, which is bordered by the 405 Freeway, Jefferson and Centinela belongs to the del Rey Neighborhood Council. David Voss made a Motion that the boundaries described in Article III be accepted. Bill Ballerini seconded the Motion. The Motion passed unanimously.
- VII B District Representatives "District residency ....determined by street address with boundaries running down the center of the roadway..." David Voss made a Motion to accept this Bylaw change. Bill Ballerini seconded the Motion. The Motion passed unanimously.

#### **Public Comment:**

- Robert Acherman Westchester Resident submitted 5 pages of testimony opposing the Bylaw changes.
- VII B1 a "In advance of every other election beginning in 2008...ad hoc committee to review and adjust the district boundaries...to reflect changes in population..." shift suggestions would need full Board approval. David Voss made a Motion to accept this Bylaw change. Bill Ballerini seconded the Motion. The Motion passed unanimously.
- VII B.3 Description of non-residential seats David Voss made a Motion to accept the descriptions as suggested by the Bylaw Committee. Bill Ballerini seconded the Motion.

David Coffin made a Friendly Amendment that the Education Seat be described as a Kindergarten 12 grade educator at one of the schools located within NCWPDR boundaries and remove the reference to LMU. The FA was accepted by Maker and Second.

Bill Ballerini, Stephen Bentley, Sibyl Buchanan, Judith Ciancimino, David Coffin, Robert Dalton, Pam DeArmas, Tom Flintoft, David Gray, Clarence Griffin, Cyndi Hench, Terry Issac, Geoff Maleman, Terry Marcellus, Nancy Niles, John Ramey, Kathy Santos, Denny Schneider, Mary Taylor, David Voss and John- David Webster voted Yea. Frances Stronks Abstain from voting. The Motion passed.

- Article VII D1 Election held on two days in October in even-numbered calendar years David Voss made a Motion to accept the Bylaw Change. Bill Ballerini seconded the Motion. The Motion passed unanimously.
- Article VII D9 "A Director may serve no more than eight consecutive years in any one seat or office.....must be off the Board for one election cycle before regaining eligibility to serve."

David Voss made a Motion to accept the Bylaw change. Bill Ballerini seconded the Motion.

Cozette Vergari made a Friendly Amendment to change "no more than 8" to "not longer than 8." The FA was accepted by the Maker and Second. The Motion passed unanimously.

- Article VIII A2 President Elect David Voss made a Motion to Elect a President Elect at the time of the Election of the President. Bill Ballerini seconded the Motion. Sibyl Buchanan, Judith Ciancimino, Pam DeArmas, Tom Flintoft, Geoff Maleman, Terry Marcellus, John Ramey, Kathy Santos, Denny Schneider, Mary Taylor and David Voss voted Yea. William Ballerini, Stephen Bentley, David Coffin, Robert Dalton, David Gray, Clarence Griffin, Cyndi Hench, Terry Issac, Nancy Niles, Frances Stronks and John-David Webster voted Nay. By a vote of 11 to 11, the Motion failed.
- Article VIII A 1, 3, 4, & 5 The wording was change to clean up the language; there were no substantive changes. David Voss made a Motion to accept the Bylaw changes. Bill Ballerini seconded the Motion. The Motion passed unanimously.

Article VIII B3 – It was recommended that "Seat 27- Recognized Community Organization Volunteers" be eliminated. This would reduce the number of Board Seats to 30. Geoff Maleman currently holds this seat and he will remain on the Board until the end of his term. David Voss made the Motion as stated. Bill Ballerini seconded the Motion. The Motion passed unanimously.

2. Motion that the NCWPDR send a letter to the Department of Transportation and/or any other applicable governmental agency requesting the creation of an optional straight/right turn lane from the middle lane of Westbound 76<sup>th</sup> Street onto Northbound Sepulveda Boulevard (Ramey) – moved to Consent Calendar.

3. Motion to approve the Government Affairs/City Services mission/vision statement (Ramey) – moved to Consent Calendar.
