**Robert Acherman** – Flight Path Learning Center – requested that we support an effort to change the name of 89<sup>th</sup> Street between Sepulveda Eastway and Sepulveda Westway to Howard B. Drollinger Way. Howard's birthday is in June and it would be nice if it could be done by then.

**Patricia Morrison Lyon** – Westchester resident – Announced that the placing of a plaque naming the community room in the Westchester Library the Mary Lou Crockett Room is scheduled for January 31, 2008. A reception will be held from 4PM until 7PM, the public is invited.

**Beth Barry** - Westchester resident - lived on Reading east of Airport Boulevard and South of Manchester until recently. She moved, in part, because there are no street lights making it easy for drug houses, gangs and taggers to operate. Families who live on Reading don't go out at night because of the hostile atmosphere. She asked that we support an effort to install solar-powered street lights on Reading. She also asked that we install speed bumps to slow down the vehicles that speed up and down the street, further endangering the residents.
