 - 1. Melissa Ramoso, Ted Lieu's Office- SB336- Emergency room crowding is moving through and will require hospitals with emergency rooms to have proper procedures. This bill is moving into Appropriations Committee. Another bill is mandating micro chipping dogs. SB 746- You cannot go to a tanning booth under the age of 18. This just passed. SB 917- This will make fines more stringent for people who neglect their animals. Budget- Vehicle License fees have gone up, and sales tax has dropped to 8.75%.
 - **2. Mike Castillo, Assemblymember Bradford's Office-** Budget- programs that have been cut are Federal matched, which means the state is losing more money for programs. Partial funding has been added in to help support Adult day healthcare.

Some of the people who have been living here have been put into substance abuse programs and the hope is to have people get into programs or housing.
