- 5. <u>Announcements</u> from Local Education Group Representatives included:

Action Item One: UPDATE: Department of Neighborhood Empowerment's Funding Update: Board Members & Awards to Schools

1. Due to the Neighborhood Councils' letters in opposition to current policy with regards to Neighborhood Purposes Grants, the Department of Neighborhood Empowerment has updated their policy to as follows:

"The Office of the City Attorney does not believe that the conflict of interest laws would preclude a NPG being provided to a school for a general item that is available to all students, e.g., if the grant is for a playground, a board could award the NPG even if the board member's child will use the equipment. However, the board member should disqualify himself or herself so as to avoid any issue under the common law bias doctrine and/or any appearance of a conflict. Disqualification means the board member may not nominate his/her child's school to receive the grant, may not negotiate with fellow board members to nominate the schools of each other's children, may not fill out the NPG application, may not discuss the NPG in or outside of a meeting with fellow board members, and may not present, discuss or vote on the NPG when the item is considered. Instead, the board member must recuse him/herself and leave the room immediately once the item is called for consideration by the board. The minutes must reflect the board member's recusal.

On the other hand, a Neighborhood Council is prohibited under Government Code section 1090 from providing a grant to a school which that board member's child attends if the grant will offset any identifiable cost for the board member or have any other distinct financial benefit to the board member or his/her child. For example, the board may not fund a field trip that a board member's child would attend if the board member would otherwise have had to pay for his/her child to participate."

Action Item Two: UPDATE on the LAUSD Instructional Pathways Collaborative Work Group exploring a single- or dual-instructional pathway at Wright Middle School

- 1. The Instructional Pathways Collaborative Work Group is exploring new or dual instructional pathways.
- 2. Ms. Hildreth was not in attendance at the March 7th meeting.
- 3. The purpose of the latest meeting was to look at ways of expanding enrollment of local residents at Wright Middle School.
- 4. A secondary purpose was to explore a potential new direction for Wright's instructional pathways.
 - a. This is in response to becoming a Magnet school 3 years prior.
- 5. Enrollment Numbers
 - a. Academic year 2012-2013: 200 residential students 653 total enrollment
 - b. Academic year 2013-2014: 163 residential students 682 total enrollment
 - c. Academic year 2014-2015: 183 residential students 696 total enrollment
- 6. Chamber Survey: The LAX Chamber of Commerce is also collecting information from local commercial businesses on their experience with local education.
 - a. The Chamber is exploring advocacy towards the creation of a facilities task force to explore issues of space and crowding in local schools.
 - b. Parents are mostly looking for consistency and peace of mind that there is a set pathway for their child
- 7. The NCWPDR Education Committee voted on developing a brief survey on what elements are attractive for parents sending their children to local schools.
 - a. So moved: John David-Webster and Matt Tecle carried.

Action Item Three: UPDATE on Westchester Secondary Charter School (WSCS) Facilities Challenges

- 1. Janet Landon: Principal at Westchester Secondary Charter School updated the Committee on developments at her school.
- 2. LAUSD has offered WSCS a new space even further away than their first suggestions.
- 3. There are currently 300 students at WSCS.
- 4. The WSCS have reached out to all political constituents and feel they have exhausted all options.
- 5. The NCWPDR Education Committee voted on writing another letter to Board President Steve Zimmer to advocate on keeping WSCS in Westchester.
 - a. Motion approved.

Action Item Four: UPDATE - Tour Local Schools

- 1. The NCWPDR Education Committee voted on touring local schools.
 - a. Motion approved.

The next NCWP Education Committee meeting is April 27, 2016. Meetings are regularly scheduled on the fourth Wednesday of every month.
