Presentation by Chris Alford, VP of Finance of Otis College, regarding Otis College's proposal to acquire an area of the North side land from LAWA that is adjacent to their Westchester main campus so that they can consolidate their other campuses and stay in Westchester. Otis moved here in 1997- grew enrollment from 650-1200- added successful departments. Looking at ways to expand the campus. Last year they entered

into conversations with LAWA about purchasing the land on LaTijera and Loyola St. It will be developed as a low rise development.

- b. Presentation by Pat Brubaker, Westchester Village Network, regarding request for \$5,000 grant from NCWP.- Volunteer-nonprofit- to keep seniors in their home as long as possible. They assist with household chores, shopping, doctor visits, dog walking etc. There are 532 people over the age over 65 in the Westchester/Playa del Rey area. Company has not started serving the community. Requesting funding to complete the website, 501 3c application, voicemail, compose brochures and logo design. Forward funding goal of 200,000- Executive Director and office space.

M/S Donell/Stronks -Donell spoke in favor of the motion...however company is in its initial stages. **Buchanan-** raised questions about the budget- how much have they received so far? \$561.00. **MacLellan** - would like to see the approval of application of non-profit status, **Stronks** spoke in support, **J.D** –spoke in support. **Taylor** spoke against- due to the lack of approval of nonprofit status and it's a large amount of NCWP budget. **Niles** spoke against due to the lack of nonprofit approval. **Webster-** suggested staggering the payments. **Donell-** suggested going back to committee once the nonprofit status is approved. **Ehlers** spoke in support to give the full funding of the project. **Donell** withdrew the motion.
