Re Support for ZA-2018-1624-CUB 8415 S. Pershing (Hacienda Playa)

The Neighborhood Council of Westchester Playa Board has voted to support Conditional Use Permit ZA-2018-1624-CUB from applicant Hacienda Playa (8415 S. Pershing, 90293).

CUB application details include the sale and dispensing of a full line of alcoholic beverages for on-site consumption in conjunction with an existing 2691.25 square-foot restaurant with 90 interior seats, providing limited live entertainment such as live music/mariachi (indoor/covered patio), karaoke and 1 video game machine (indoor), a 679.25 square-foot covered patio with 60 seats, and a 301 square-foot patio in the public right-of-way with 18 seats providing background music. Amplified music, live music or entertainment on premises shall cease at 10:00pm daily and recorded music on patio facing Pershing Drive shall cease at 10:00pm daily. Proposed hours of operation from 7:00am to 12:00 am, Sunday to Thursday and 7:00am to 1:00am, Friday and Saturday in the C2-1VL zone.

In addition to the application details above, on request of NCWP, the Hacienda Playa operator has made the following additional agreements:

- Design and posting of signs requesting patrons and employees avoid excessive noise, in consideration of the immediate neighbors;
- New employee parking policy, training, and compliance agreement;
- Instituting a 24 hour "hot line" for the community to report problems at the restaurant. This line to be monitored by the restaurant's manager, and respond immediately.
- Agreement to add to the CUB application specific decibel levels to reinforce noise control (65 decibels day and 55 decibels at night.)
