Katherine Evans – Is the system Solar powered? Yes

Mark Redick – Questioned whether completion of installation in could be done in 9 months? Yes (outside of EIR process)

**Denny Schnieder –** Questioned the cost of operation – does the passenger pay? Yes either per ride or a pass; Solar panels only good during daylight hours – also use the 'grid'

Lance Williams – How would the stations be set up – for example, where to you get on/off? – stairs or

**JD Webster –** Is there an installation of the system anywhere? Yes, in Morgantown, West Virginia which has a PRT System that was installed in1985; Heathrow; a couple of Germany; Magdar.

What are you asking of the NCWP? The presenter referred to the LAX expansion plan and asked that folks make comments in favor of a JPOD or like system included in the LAX plan.

**David Voss** – Asked if there a functioning JPOD installed? No, however the same 'group' installed Morgantown system in 1985 since that time the system has been updated however, none has been installed.

**Jack Topal –** Asked if there a prototype? – a scaled model is available however, no prototype.

#### 8. Motions/Actions Items and Related Public Comment

### 1. Discussion Calendar

Motion to oppose the currently proposed LA City Community Care Ordinance unless and until the
City can guarantee that there would be no loss of federal housing funds, no evictions of veterans in
Mar Vista and Del Rey and no evictions of the six formerly homeless individuals from Westchester
Park who currently live in shared housing. (HVL)

Booker Pearson gave overview of the ordinance and the motion. Recommend that we oppose the Ordinance because it is thought that they ordinance has a large loop hole would not prevent multiple living in a home as long as there was a single lease. There is a chance of a loss of \$100 millions of federal homeless funds. The NC is revisiting this issue due to the fact that new facts came forward such as the loss of funds, probable increase in homeless (up to 43,000), cost of lawsuits. Passed unanimously in Committee.

David Voss – the ordinance has been tabled by the City Council, but called for a point of order that the NC has already voted on the issue and therefore this issue can not be revisited by the NCWP.

Geoff Maleman referred the issue to the Government Affairs Committee to determine if there has been a change. Next meeting October 15<sup>th</sup>.

#### Public Comment:

Mike Arnold – LA Homeless Services Authority – the ordinance has changed significantly, and would result in the reduction of the number of available reasonably priced housing.

Paul Dumont: Oppose the ordinance and in favor of the motion as presented tonight. The original ordinance has changed from what the NCWP has voted on

Kaitlyn Brugh – lives in a sober living home, spoke for the motion and against the ordinance.

Jesus 'Jesse' Rubacalva: spoke in favor of the motion, against the ordinance, sober living resident.

Alisa Orduna: from the United Way, spoke in favor of the motion, against the ordinance.

Maria Fisk: Granada Hills Homeowners Association, spoke against the motion and for the ordinance.
