PROJECT DESCRIPTION

The El Segundo Blue Butterfly is a federally endangered species. It is endemic to coastal sand dunes and is now found only in a few locations in Los Angeles County & Santa Barbara. Urban development has significantly reduced the size and quality of its habitat. Our goal is to provide a quality habitat which is essential for its survival.

Our nonprofit Friends of the Jungle intends to create a biodiverse environment for the federally endangered El Segundo Blue Butterfly to flourish. We have partnered with Friends of Ballona Wetlands, a Wetland's conservancy group, to ensure the optimal combination of vegetation is planted which is vital for the Blue Butterfly to thrive. This project will conserve and restore a degraded non-native Upland Habitat into a healthy ecosystem by installing specific native drought tolerant plants. The proposed site will maintain the flight path of the butterfly between the El Segundo Butterfly Preserve and Ballona Wetlands. This urban green space will become a landmark where the public can reconnect with nature and enjoy the scenic vistas of the habitat & Ballona Wetlands.

Our project is on City owned property (346 Culver Blvd, Los Angeles, CA 90293). Presently, polluted water from this dirt lot floods the street and makes its way to the Ballona Wetlands. Our nature-based solution will filter and clean the polluted water, prevent erosion, prevent flooding and migration to the Wetlands. Our sustainable landscaping includes trees and plants which will help reduce carbon emissions. These elements will help build climate change resilience to create a healthier watershed.

Located next to the public access stairs, this site connects the residential area to the business district. This destination will increase foot traffic which will enhance commerce for the local businesses. This will also reduce the need for vehicular transportation and create a more walkable neighborhood. We plan to install lighting in the area to improve community safety and accessibility at night.

Mural art will be installed which shows the Blue Butterfly in its natural habitat. An educational placard will be installed with information on the Blue Butterfly. These installations should promote stewardship of the environment.

We have support letters from Los Angeles City Councilman Mike Bonin, Neighborhood Council of Westchester/Playa Del Rey, nonprofit Friends of Ballona Wetlands and City of Los Angeles Bureau of Sanitation.
