- 1. Call to Order Vice President Cooley-Strickland called the meeting to order at 6:30 p.m.

5. Announcements from Governmental Representative (limit to 3 minutes please)

**LAXPD Chief Cecil Rhambo** introduced himself and spoke re: LAX Airport Police operations, LAXit program, homelessness, traffic, and additional security since tensions with Iran have increased.

**LAPD SLOs Sophia Castaneda and Luis Pinell** spoke re: a ring of new burglaries (four male blacks, wearing ski masks who strike residential areas of Westchester during daytime hours through windows and sliding doors). She encouraged people to call 9-1-1 if residents see anything suspicious in the area and express urgency when speaking to the dispatcher. She also discussed new laws related to in-vehicle dwelling, Amazon locker locations and a new city sanitation strategy.

**Booker Pearson,** representing LAHSA, spoke re: the January 22 homeless count and 2019 count results. For more information or to participate in this year's count, visit <a href="https://www.theycountwillyou.org">www.theycountwillyou.org</a>.

**Geoff Thompson**, LAX Liaison to Councilman Mike Bonin's Office, spoke re: LAX operations and the recent taxi protest regarding the LAXit lot.

**Matt Tecle** of L.A. City Councilman Mike Bonin's Office spoke re: PLUM Committee will review Bonin's proposed Ellis Act eviction motion to ask the city to put a moratorium on such evictions under certain conditions and added that the FEIR (Final Environmental Impact Report) for the Ballona Wetlands restoration was released in December. The next step will be a Notice of Determination by the state regarding what it plans to do with the wetlands restoration project.

**Gibson Nyambura** of DONE spoke re: BONC motion regarding policy for censure and board member removal as well as a social media policy for NC board members. In addition, he said the city is planning a data literacy program, training and handbooks for board members.

**Puza** announced LMU spring semester will begin January 13, hoping to host voting and the January 26 Wine Classic.

**Silva** spoke re: modernization updates, major closures internal to LAX are coming to facilitate construction and added that on January 15, LAWA will send out its first wireless emergency alert test.

**Maleman** announced that Deborah Hong of LADWP was unable to attend this meeting but asked to share the following:

- 1. Century Trunk Line water project
  - a. The contractor is currently doing some preliminary work along 98<sup>th</sup> St. Currently there are no lane closures and temporary drilling is happening in various locations. We expect the traffic control plan to be approved by LADOT any day now and once approved, we will begin full construction.
  - b. Once we start construction, 98<sup>th</sup> St will be converted into a one-way street going west between Bellanca and Vicksburg. See attached notice.
  - c. To facilitate traffic along Century Blvd, LADWP will install a protected left-turn arrow on Century at Bellanca. The current status is that the drawings are approved and we are waiting for final approval from LAWA. Installation of the turn signal will take a few weeks.
- 2. Sepulveda and Lincoln water valve
  - Cal Trans permit is approved and we expect to begin digging around the end of the month.
  - There will be no lane closures and work will be primarily in the landscaped median at the intersection of Sepulveda and Lincoln, just south of In-n-Out
  - c. Valve installation work will take place overnight on one Friday the date is still be finalized but we expect it to be perhaps at the end of January or beginning of February. See attachment.
