Frisch of Senior Committee – reported senior symposium, hoping to expand the senior committee to reach out to seniors in need and connect them to available services

Lyon of Planning and Land-Use Committee – reported that the Mazzoni project in Playa del Rey went to Area Planning Commission, which instructed the developer to follow the PDR Specific Plan re: height/density restrictions and the developer agreed to all the restrictions imposed by the Commission and to create a construction hotline; she also spoke re: antimansionization issues, short-term rental legislation, liquor licenses in Playa Vista's Runway project,

Lyon of Ad Hoc Homeless Committee – reported that NCWP participated in LAHSA homeless count, which identified nearly 500 homeless people in the Manchester Square area and that by late August, LAWA plans to clear that area in anticipation of construction.

Hanson of Budget & Finance Committee – reported that the committee is seeking additional applications for community grants from non-profits.

Lyon announced that the quarterly LMU community meeting will be held on March 8 and will be focused on a forum for those interested in renting to LMU students, property managers and community members to understand the pitfalls and opportunities of dealing with students.
