  - a. LAX Liaison for Councilman Mike Bonin: **Geoff Thompson** [geoff.thompson@lacity.org](mailto:geoff.thompson@lacity.org) spoke re: report on behalf of Hannah Levien of Councilman Bonin's Office. He added that Councilman Bonin submitted three earmark requests to Congresswoman Maxine Waters' Office and two were accepted by the Congresswoman: 1) the Lincoln bridge replacement project and 2) the Century Boulevard Streetscape Plan. Thompson also gave an update on the ATMP project and announced that BOAC will discuss continuing funding for the LAX Liaison position.
  - b. **Mario Hernandez** of Department of Neighborhood Empowerment provided an update on Neighborhood Council happenings, funding dates, check payment and bank transaction deadline, etc.
