NCWP Opposes Bonin Plan for the Homeless

At a special meeting on Thursday, April 29, the Neighborhood Council of Westchester Playa voted 18-3 to oppose Councilman Mike Bonin's plan to temporarily house the homeless at sites on countyowned beaches, including Dockweiler State Beach in Playa del Rey, Fisherman's Village in Marina del Rey, and Will Rogers State Beach in Pacific Palisades. His proposal calls for the City Council to instruct the office of the City Administrative Officer to "evaluate and identify funding" for temporary, singleoccupancy tiny houses as well as safe camping and safe parking in parking lots and RV parks already at the locations.

Hundreds of people either spoke at the special meeting or wrote emails to board members on both sides of the issue – one that has polarized the community. In March, the NCWP approved a letter asking the city to investigate the feasibility of creating a specific and defined area (Safe Camping Zone) within Westchester Park for "our unsheltered

neighbors and vehicular dwellers to reside with centralized services to include suspending enforcement of LAMC 63.44 in the designated area and to include enforcement of LAMC 63.44 in the park outside the designated areas."

The Neighbhorhood Council's action is advisory, and Bonin has indicated that he will continue to move forward on his plan.

""None of the locations we've identified are ideal, and I'm always open to other suggestions," he wrote on Twitter. "But we've looked long and hard. There or no ideal places on the Westside, but that doesn't reduce the need or urgency to act."

Bonin's plan comes in the wake of several violent incidents in Westchester Park over the weekend and growing concern about safety in the existing encampments and the neighborhoods that surround them.

Join CERT, Help Get **Prepared** for an Emergency

In Los Angeles, there are more than four million people in the city every day, whether they're residents or visitors. The diverse nature of the city, not to mention more than 470 square miles of geography, make a high risk situation in the event of a major disaster. Thankfully, the city has not suffered the types of catastrophic earthquake, flood, and

other FEMA categorized events that can bring a city to its knees. To ensure that the population has the best possible chance of surviving a disaster and thriving afterward, the LAFD supports and trains residents to be disaster first responders. The program is called Community Emergency Response Team, or CERT.

WHO CAN JOIN CERT?

Anyone in good health and with a sense of community can become a part of CERT. If you become a CERT member, you will learn about important life-safety support techniques. You will, however, not be expected to place yourself in dangerous situations, either in the training or when a disaster strikes.

Training includes:

- · Learning to suppress small fires
- · Basic first aid, including ABC treatment, treatment for shock, and related techniques
- · Evacuation tactics and how to collaborate with city agencies to support neighborhood exits · Search tactics
- · Communications, including the use of radios



A key factor for CERT members is the ability to spontaneously organize and activate themselves in the event of a major disaster. If there is a significant earthquake, phones and other communications channels may be interrupted. CERT members will know where to go, how to organize their efforts, and will get to work without any specific order being issued.A CERT member's first responsibility is to his or herself, then his or her family, and finally his or her community.

HOW TO BECOME A CERT MEMBER

LAFD CERT members drillCERT members receive 17 1/2 hours (one day a week for seven weeks) of initial training. The 7-week course is followed by full-day bi-annual refresher drills, and an opportunity to assist the LAFD at local incidents. CERT training is provided free of charge within the City of Los Angeles to anyone 18 or over.

Classes are taught mornings, afternoons and evenings continually throughout the year in locations all over Los Angeles.

Todd the Volunteer Named Star of the Neighbhorhood

The Neighborhood Council of Westchester/ Playa is proud to announce that Todd "The Volunteer" Odin has been named the 2021 Star of the Neighborhood. He will be recognized in the annual Fourth of July Parade on Sunday.

When people see Todd picking up trash on the side of the road, it's not hard to think that something unusual is happening. Todd routinely wears a white T-shirt and a Dayglow orange vest, but he's not part of a city work crew — it's just him out there, and a single handcart bursting with well-worn tools.

But three words emblazoned in thick black marker on handwritten signs and the back of his vest identify this man as someone who has christened himself with a unique identity rooted in dignity through selfless hard work: "Todd the Volunteer."

Over the years, Todd the Volunteer has stuffed hundreds of plastic trash bags with litter and debris he's singlehandedly picked up along local streets, arranging them in neat piles or orderly rows that can stretch for a whole city block. From Abbot Kinney and Washington boulevards to the Ballona Wetlands to Manchester Avenue and Sepulvedda Boulevard, it seems Todd is everywhere.

"Every person that has ever stopped has said, 'Man, I wish there was more people like you!" Olin told The Argonaut newspaper.

As Todd the Volunteer, Olin has been laboring to win recognition of the dignity and untapped potential of homeless people since becoming homeless himself in 2015.

"A lot of people don't think I look like a homeless person. ... But what does a homeless person look like?" he asked.



Olin describes himself as a "pioneer" who's carving a path along which any able-bodied person of sound mind can work his or her way off the streets and out of homelessness.

"There's barriers, when you're homeless, to getting a job— like not having a resume or being able to get ready for an interview. It's difficult to wake up behind a dumpster and get to your job at eight o'clock," Olin told the Argonaut. But the way he sees it, "Your interview is right there on the street. I've had over 60 job offers doing that."

He recognizes that his decision to remain homeless despite other opportunities confounds some of those who stop to donate water, clothing or cash.

"I could have been off the street after three months, when I got my first job offer, but I knew that I was on to something. I couldn't take a job without doing everything I possibly could to get this to become a national thing," he said. "I believe in my mission. If I can get this plan out there and available to homeless people as an option, what greater accomplishment could there be?"
