4) Please describe the purpose and intent of the grant.

The grant would be used to support the work of Nuestros Alimentos (aka Nourish LA). Nourish LA's mission is to cultivate a vast network of partnerships to ensure food is not wasted, people do not go hungry and that all excess green waste is then diverted to animal husbandry and green spaces (compost). Every weekend we distribute groceries to thousands of Angeleños experiencing food insecurity. Our donated food comes from farms, community trees, gardens, restaurants and supermarkets where it would have otherwise gone to waste. Since March of 2020 we have diverted millions of pounds of food from going to waste and given out tens of thousands of bags of food in addition to the thousands of pounds of compost diverted to community gardens.

5) How will this grant be used to primarily support or serve a public purpose and benefit the public at-large. (Grants cannot be used as rewards or prizes for individuals)

Thousands of members of the public benefit directly from the services we provide every weekend. In addition to the food saved from going to waste and distributed to those in need we have other programs to address food insecurity including distributing seeds and cultivating community gardens. The grant would help with some of the costs, which are numerous, associated with our programs including rent for refrigerated storage, transportation, supplies and administrative expenses.
