## **Item 2: Discussion Items**

### 2.1: Home Sharing Ordinance enforcement.

City enacted the Home Sharing Ordinance (18593) in Dec. 2018. Since then there has been a lack of enforcement by the city. PLUM Committee passed a motion (14-16350S10) directing the City Council to create an enforcement action plan.

**Public Comment**: Linda Kokelaar supports better enforcement. Public Comment email attached. Chip Mallek, enforcement is not living up to the ordinance, resulting in "rogue hotels" across the city. **Committee Discussion**: Mannix supports better enforcement. Thrower Conyers commented that Councilmember Bonin wrote and supports the enforcement motion. Miller, what strategy is available to us to support the enforcement of this motion.

**Motion to recommend the Board support**: Recommend the board support Los Angeles City Council Motion 14-1635-S10 to create an enforcement action plan for Ordinance 185931which was adopted by the Los Angeles City Council on December 7, 2018.

**2.2: 7346 Rindge Ave., Playa del Rey**, applicant seeks approval to demolish existing 1,124 sq. ft. sfdand the construction of a new two story single family dwelling over a street level garage and basement. Construction of a 6,192 sq. ft. dwelling, max. height of 45 ft. with an additional 5 ft. rooftop elevator housing, Mello Act approval and a Coastal Development Permit.

Chair Ross informed the Committee that due to personnel changes the Applicants Representatives they would not be presenting this evening and are expected to be at the August meeting. Chair Ross provided and overview of the project history.

Stakeholder and neighbor to subject property talked thru the neighborhoods issues with the project. No certified architect on the plan, plans have not changed, applicant not engaged with community. Has avoided meetings with PLUC even though PLUC made multiple efforts to further discuss the project. City Planning issued

the applicant permits for the project without assuring that they had been thru the Neighborhood Council process. Neighbors appealed the project after the City approved it. Project is still on appeal. Applicants representative had made the request to PLUC that they be able to come back to present.

Public Comment: None

**Committee Discussion**: Miller, how can the city approve a project like this without assuring that it's gone before the Neighborhood Council? Thrower Conyers, ministerial project approvals do not go thru PLUC. Birkett, What is the City process to place a project on the Early Notification System. Can the city send someone to discuss that process?
