Motion is instructing the City Attorney, in consultation with the Executive Director of the Ethics Commission, the City Administrative Officer, and the Chief Legislative Analyst to provide a detailed report within 90 days with recommendations for establishing a permanent Office of Compliance that would proactively assist Councilmembers with identifying and avoiding potential conflicts of interest by reviewing financial disclosure and other forms of Councilmembers and upcoming City Council and City Council Committee agendas to identify potential conflicts.
