- 1. Call to Order– President Gerez called the meeting to order at 6:36 p.m.
- 2. Salute the Flag President Gerez led the flag salute
- 3. Introductions
- **4. Consent Calendar:** (The following items will be treated as one item and enacted with one vote unless a Board member or a stakeholder requests that an item be placed on the Discussion Calendar.)
  - 1. Approval of Minutes of October 2023 Board meeting
  - 2. Motion to receive and file the Treasurer's Report and MER for September
  - 3. Motion to oppose the Housing Element's proposed rezoning and densification of R1 and multi-family neighborhoods beyond what SB9 and ADU laws allow. We demand that Mayor Bass and all Councilmembers representing WRAC neighborhoods (Park, Yaroslavsky, Hutt and Raman) stand up for our communities and direct the City Planning Department to reject the upzoning of our single-family and sensitive multifamily neighborhoods, and instead, locate all upzoning on our underutilized commercial corridors.   - 7. Motion to oppose the proliferation of distracting digital billboards on city streets and in view of busy freeways. We specifically request our Councilmember to seek the removal of the four Metro TCN billboards in our community.

  - 8. The NCWP, a member of the Westside Regional Alliance of Councils, is concerned about the passage of CF 23-0360, which nullifies Sections 22.482(a) and 22.602 of the Administrative Code and changes the parking space replacement policy when LADOT parking facilities with spaces greater than 25 are transferred to the Housing Department for redevelopment as affordable or supportive housing. The NCWP is sensitive to how difficult it can be to develop affordable and supportive housing in Los Angeles. We recognize there is a shortage of affordable and supportive housing and believe that Los Angeles would benefit from making it easier to build such housing. Until now, when LADOT-managed parking facilities have been redeveloped, all the

parking spaces had to be replaced, increasing the cost of the development. With the passage of CF 23-0360, the spaces will no longer be required to be replaced. However, we believe that the needs of small businesses, including the need for parking for their customers, have not been adequately considered with the nullification of Administrative Code Sections 22.482(a) and 22.602 and establishment of the new parking space replacement policy.

Therefore, we respectfully request that Councilmembers representing WRAC member councils who are also members of the City Council Transportation Committee – Councilmembers Park, Yaroslavsky, Raman and/or Hutt – bring a motion in Los Angeles City Council forthwith to further amend the Administrative Code to include concessions for small businesses by replacing the new parking space development footprint. The City should determine how much parking to replace by using a sliding scale for parking replacement based on prior utilization, as well as the availability of nearby public parking, rather than never requiring any replacement. - 9. The NCWP, a member of the Westside Regional Alliance of Councils, requests that the Metro TCN program be referred to the LA City Council Transportation Committee and LADOT for their consideration before a final decision to implement the program is voted on by the City Council. The Transportation Committee and LADOT need to weigh in on the safety of this program through the study and review of current and historical research that has been done on roadway user distraction with digital billboards and changing message signs. The NCWP requests that the City revises the LAMC/Zoning to be implemented in Community Plan updates, Westside Transit Neighborhood Plans and TOC/Density Bonus ordinances to standardize setbacks, landscaping, open and recreational space, setbacks, massing and zoning, in accordance with the specific preferences communicated to the City by the relevant NC/CC for each area. Carcel (LAWA) provided the following report:

On Wednesday, October 25th, the LAWA Community Relations team hosted record-breaking participation at our 8th Annual LAX Aviation Career Day event, where more than 1,100 local high

school students engaged with aviation companies and agencies to learn about career paths in the industry. The event — which was held on the airfield ramp at the Flight Path Museum — featured commercial aircraft, equipment demonstrations and a career fair with representatives from more than 30 agencies, including airlines, law enforcement, construction and more. Students attended from 13 Los Angeles Unified School District schools and several neighboring schools.

The Westchester Family YMCA hosted its annual Halloween Spooktacular celebration, with over 900 community members in attendance. Guests enjoyed a haunted maze, carnival games, choreographed dance routines, a costume parade, food trucks and more. The LAWA Community Relations team sponsored the free event and were onsite to hand out giveaways and answer questions regarding LAX's transformation projects.

The Airport Police Division (APD) hosted a Trunk-or-Treat Halloween event for members of the APD and LAWA, as well as the local community, at the Los Angeles Airport Police Station. This was the first year that APD was the event's sole organizer, after hosting it in partnership with LAPD in the past. The event was well attended and included a costume parade, carnival games, a raffle and a contest for the best decorated trunk. Thank you to Paula for helping to get the word out, it was a very successful event.

In partnership with the LAX Coastal Chamber of Commerce, LAWA is co-sponsoring the upcoming State of LAX. The event will take place this Thursday, November 9th. The event brings together top executives from the aviation, construction, hospitality and transportation industries.

Finally, as we move into the holiday season, we want to encourage the use of our cell phone waiting lots to help alleviate traffic congestion. The lots are free and open for you to use until your passengers are ready to be picked-up from the terminal curb. Cell Phone Waiting lots are available at 96th Street & Alverstone Avenue and 96th Street & Vicksburg Avenue.

Also, available for folks is our economy parking lot and our new budget parking lot. Guests are highly encouraged to use the online booking system at parking.flyLAX.com which allows customers to reserve their space ahead of time and take advantage of discounts. Complimentary shuttle service is available to and from the parking lots and Central Terminal Area.

The economy parking lot is located at 6100 W. 94th Street, Los Angeles, CA, 90045) and more than 4,000 parking stalls available, including 305 active EV chargers. \$35 Maximum for each 24-hour period.

The budget parking lot is located at 5455 W. 111th Street between Aviation Blvd. and La Cienega Blvd., the former location of Parking Lot E, LAX Budget Parking offers 2,600 spaces. \$20 Maximum for each 24-hour period.
