## **Neighborhood Purposes Grants**

Neighborhood Purposes Grants (NPGs) provide NCs opportunities to develop partnerships with local 501(c)(3) nonprofits and public schools to build community and enhance neighborhoods in the City of Los Angeles. Projects and activities supported by NPGs vary widely and can include, but are not limited to:

- The Arts
- Beautification
- Community Support
- Education
- Community Improvements

NPG-funded projects and activities must be for a *public benefit* and purpose, **open**, *accessible*, and *free of charge* to stakeholders.

Grants approved by NCs exceeding \$5,000 involve further review and possible City contract by the Office of the City Clerk.

There are two NPG Information Packets; One for prospective applicants to help guide them in the application process, and one for NC board members outlining considerations and factors to keep in mind while evaluating NPG requests.

A "Project Completion Report" template is also provided to help ensure accountability in the use of Grant funds and help demonstrate how NCs and their partners are supporting L.A. communities and stakeholders. NCs and NPG recipients are strongly encouraged to work together to complete and submit the Report at the conclusion of the project.

SECTION II - PROJECT DESCRIPTION

Contribute to the purchase of 4 benches for Westchester Recreation Center, placed around the Facility. These benches have been a desire of park leadership for several years. These benches will help all park participants enjoy the park and provide additional seating in several areas around the facility, including the senior center.

Estimated cost for the four benches, \$4,716.88

5) How will this grant be used to primarily support or serve a public purpose and benefit the public at-large. (Grants cannot be used as rewards or prizes for individuals)

Westchester Recreation Center is a City of Los Angeles public park serving the community of Westchester and Playa del Rey. These new benches will serve all visitors to the park, in particular visitors to the Senior Center.

Funds will go through the LA Parks Foundation (LAPF), a 501c3 created to assist fundraising for the improvements and beautification of all LA Parks (www.taparksfoundation.org). This grant to the LAPF will be designated for Westchester Park.

Westchester Rec Center, Senior Director Mychal Lynch and Senior Center Director, Kirstin Zullo have recommended these benches. Mychal Lynch provided the \$4,714.88 quote for 4 benches from a City of Los Angeles, Rec and Parks qualified vendor. See document showing the selected benches, attached.
